Qualifying exhibits will be displayed in the L. Lewis Pavilion during the week of the fair. **Exhibits and any associated paperwork (if not previously submitted) must be delivered on the Saturday prior to the opening of the fair between 12:00 p.m. and 7:00 p.m.** Exhibits must be picked up on the Sunday following the final day of the fair between 9:00 a.m. and 1:00 p.m. Please bring your exhibit tags at the time of pick-up.

Rules and Regulations:

1. All articles must be the handiwork of the exhibitor and in clean, exhibitable condition.
2. Exhibitors may enter one item per class, with a maximum of five entries in the Fine Arts Department. All entries must have been completed within the past two years and may not have been previously exhibited at the Yamhill County Fair. Entries may not exceed 24" x 36" in size. If an exhibitor enters the maximum of five items, no more than two entries may be entered in any one division.
3. Competition is open to amateur artists only. An amateur is defined as an individual who engages in the arts for personal enjoyment, creative expression, or learning rather than for financial gain. All entries must be suitable for family-friendly viewing. The superintendent reserves the right to reclassify any entry if deemed necessary by the judge.
4. Professional artists may enter exhibits for ribbon competition only and are not eligible for premium awards. A professional is defined as any individual who has taught art, exhibited artwork in a gallery, or sold artwork for profit.
5. The artist's name and address must be securely attached to the back of each entry.
6. All entries must be securely framed or matted and equipped with appropriate, securely attached hangers. Taped hangers are not permitted. Glass is not allowed in any entry. Entries that are improperly framed, matted, or hung may be disqualified.
7. The Fine Arts Department will take reasonable precautions to ensure the safety of all exhibits but assumes no responsibility for loss or damage.
8. Exhibitors must ensure entries are submitted in the correct age division. Divisions are defined as: A — Adult (ages 19 years and older); Y — Youth (18 years and under).
