I understand that this is an application for space only, and is not a commitment by the Yamhill County Fair & Rodeo to rent a space to me. I certify that all information contained in this application is true and accurate to the best of my knowledge.

By my signature on this application, should I be offered a contract to be a food vendor at the Yamhill County Fair & Rodeo:

- I am submitting a \$100 deposit for my space. I understand that this deposit becomes non-refundable once I am offered a contract.
- I AGREE that I will comply with all Yamhill County and State of Oregon food, health and alcohol laws.
- I AGREE that I and my employees or volunteers will remain responsible for complying with Yamhill County Fair & Rodeo rules, policies, and regulations, as currently drafted. The Yamhill County Fair & Rodeo has the right to amend these rules, policies and regulations from time to time.
- I AGREE to hold harmless and release from liability the Yamhill County Fair & Rodeo from all claims for loss or damage of any nature caused by me or my exhibit, other vendors, or Fair visitors.
- I AGREE to expressly assume all risks of harm to me or my exhibit, including harm resulting from negligence of other exhibitors of Fair visitors.
- I AGREE to properly dispose of all garbage and waste products, including grease and other food waste.
- I AGREE to indemnify (to pay any losses, damage, or costs, including legal costs incurred by) The Yamhill County Fair & Rodeo, Yamhill County Fair & Event Center, and Yamhill County and hold them harmless concerning claims for harm to me or my exhibit and for claims made by others for any harm caused by me or my exhibit while at the 2026 Yamhill County Fair & Rodeo, including move-in and move out days.
- With this application, I agree that when using the power provided, that I do it at my own risk. I will be responsible for any and all damages that might occur when using the provided power.
